Executive Feedback on Overall Rating	There are multiple aspects of this report that are excellent, and good examples of data presentation and use. The information on evaluation participants is particularly good, as is the discussion of evaluation tools. The evaluation used a framework which is good practice, although this and the rest of the evaluation design are not discussed sufficiently. However, the major weakness of the report is the lack of a conclusions section that is a distinct requirement under UN Women standards.

Executive Feedback on Parameter 2	The report introduces the centre, its history and context, but does not provide a clear picture of the logic of the particular programme interventions or the results framework from the project. However, the stakeholder analysis - which is combined with information on the sampling and respondents - is highly detailed and provides lots of useful information for the reader.

This has to be guessed at by the reader by comparing the tools to the presentation of the findings. Everything indicates that the evaluation process was robust, but the report does need to specify this information more clearly. There is also no discussion of ethics. However, the discussion on sampling and stakeholders is very detailed and of good quality.
